ON THE APPLICATIONS of the Petitioners by the Amended Petition dated and filed December 7, 2021 (the "Amended Petition") and by the Notice of Application dated and filed March 7, 2023 (the "Notice of Application"), coming on for hearing at Vancouver, British Columbia, on March 30, 2023, and on hearing Paul R. Bennett, Nicholas Baker, and Naomi Kovak, counsel for the

Petitioners; Patrick Kurek, articling student, counsel for the Respondents Kootenay Zinc Corp, Anthony Jackson and Rob Tindall; and no one appearing for the other Respondents;

THIS COURT ORDERS that:

- 1. The service of the Amended Petition and the Notice of Application, and the materials in support of both, upon the Respondent Green 2 Blue Energy Corp, is deemed to be service on the Respondent Slawomir Smulewicz, effective March 22, 2023.
- 2. Leave is granted to the Petitioners, Malcom Runkee ("Runkee") and Greg Lomnes ("Lomnes") to rely on the Affidavit #1 of Joanne Hung, sworn on March 12, 2021, in support of their application for leave under s. 140.08 of the Securities Act, RSBC 1996 c. 418 (the "Act"), made pursuant to the Amended Petition filed December 7, 2021 ("the "Leave Application"), to bring secondary market misrepresentation claims under s. 104.3 of the Act against the Respondents Green 2 Blue Energy Corp., Slawomir Smulewicz, Michael Young and Glenn Little, (the "Green 2 Blue Respondents") and Citation Growth Corp. (formerly known as Liht Cannabis Corp. and Marapharm Ventures Inc.), David Alexander and Yari Nieken (the "Marapharm Respondents").
- 3. Leave is granted to the Petitioners Runkee and Lomnes to file the Affidavit #1 of Linda Sampson sworn March 6, 2023 in support of the Leave Application
- 4. Leave is granted under s. 140.08 of the *Act* to bring the claims for secondary market misrepresentation under s. 140.3 of the *Act* that are set out in paragraphs 153 to 165. 187 to 207, and 322 to 329A of the proposed Amended Notice of Civil Claim in BCSC Action No. S-197731 (the "Action") attached as Schedule "A" to the Amended Petition, as further particularized in those same paragraphs of the Further Amended Notice of Civil Claim filed in the Action on February 23, 2023, to the Petitioner:
 - a. Runkee to bring those claims against the Green 2 Blue Respondents; and
 - b. Lomnes to bring those claims against the Marapharm Respondents,
- 5. Leave under s. 140.08 of the *Act* to bring the claims for secondary market misrepresentation under s. 140.3 of the *Act* pursuant to paragraph 4 above is granted *nunc pro tunc* to July 11, 2019.

6. That part of the Notice of Application seeking to set aside the Notice of Discontinuance filed March 24, 2021, which discontinued this proceeding against the Application Respondent Hanspaul Pannu ("Pannu") without costs and by consent, and that part of the Leave Application seeking leave to bring secondary market misrepresentation claims under s. 140.3 of the *Act* against Pannu, are adjourned by consent of the Petitioners and Pannu.
